On December 19, 2016, The Millwood Board of Fire Commissioners held their regularMonthly Meeting at 7:30pm at Station No. 1 located at 100Millwood Road in the Town of New Castle. Present at the meeting were Commissioners: Angelo Indusi, Anthony Olenik, Dan Puszka, Jason Lichtenthal, Secretary Paul Michael Marinello, Treasurer Rose Cohen, Chief Greg Santone, 1st Assistant Chief Jorge Rodrigues, Captain Frank Nestro, and commissioner-elect Michael Wolfensohn. Absent was Commissioner Alan Schapiro.

Chairman Indusicalled the meeting to order.

The Board saluted Chairman Indusi who has served the Board graciously for a total of 11 plus years as this is his last meeting.

There was no public comment.

Chief's Report by Chief Greg Santone, attached.

Commissioner Puszka made a motion to accept Doug Lyon and Christina Araujo for active Class A membership (pending their approval by the Fire Company), Seconded by Chairman Indusi, All in Favor. Both have passed background checks and will be voted in by the Fire Company on December 20th.

Chief Santone explained that he would like to clean out the 2nd floor mezzanine at the new firehouse, and purchase shelving units to store building materials.

Commissioner Olenik made a motion to purchase 3 shelving units (60" L x 24"D x 60" H, 5 units: 72"L x 36" D x 60" H) from ULINE, the lowest bidder, at a total cost of \$1,518, Seconded by Commissioner Puszka, All in Favor. PO#174

Chief Santone stated with many new firefighters coming on board and the existence of the explorer program, that the Company needs new turnout gear for at least 5 members.

Commissioner Puszka made a motion to purchase (5) complete sets of turnout gear from MES on NYS State Bid at a total of \$16,855.10, Seconded by Chairman Indusi, All in Favor. PO#175

Chief Santone recommends using Adirondack Fire Equipment to help sell the 1990 Rescue as we anticipate the delivery of the new Rescue in the near future. Their commission would be 10% only if they locate the buyer and is not an exclusive agreement. The Board could decide to sell the vehicle by other means is they choose to. Commissioner Puszka made a motion to enter an agreement with Adirondack for selling the 1990 Rescue truck which will be deemed surplus as soon as the new truck is put into service in early 2017, and that Chief Santone is authorized to sign and return the contract, Seconded by Commissioner Lichtenthal, All in Favor.

Chief Santone also mentioned ongoing telecommunications issues with the presentation screen in the multi-purpose room as well as continued issues with several TV's in the member's room. Colortone will be notified.

As this year comes to a close, the Chief's Staff would like to thank the Board of Fire Commissioners for their continuous support and look forward to working closely together in the coming months and years. We would also like to congratulate and welcome Mike Wolfensohn to the Board, congratulate Commissioner Jason Lichtenthal on his election to the Board, and sincerely thank Commissioner Angelo Indusi for his many years of dedicated service to the Millwood Fire District. We wish the very best to everyone and their loved ones in the coming year.

Treasurer's Report by Treasurer Rose Cohen, attached.

Treasurer Cohen explained that Wex Bank, our fuel credit card provider has offered a 1.58% discount for using Wex Bank Premium and she will set up same. The program works exactly the same as the non-premium version.

There was an extensive discussion regarding the closeout of telecommunications work for the new firehouse. Commissioner Lichtenthal and Chief Jorge Rodrigues have met with Lantegrity (telecom vendor) and have a short punch list of items which need to be completed including: communications between servers at both firehouses, proper installation of the Red Alert software, and getting the security systems working/online. Commissioner Lictenthal has stated the work will cost approximately \$2,000 to complete.

Commissioner Lichtenthal made a motion to spend \$500 to begin completion of software and interfacing at Station No.1, a vote was held.

Commissioner Lichtenthal – YES Commissioner Puszka – YES Commissioner Indusi – NO Commissioner Olenik – NO Commissioner Schapiro – ABSENT Motion not passed 2- 2.

Earlier in the month, Fred Cook was hired by the District to do a video inspection of the gray water tank under the parking lot. The tests concluded that the tank is leaking as a result

of poor workmanship on the part of the site contractor Montesano Brothers. Our attorney will be notified regarding same.

There was a brief discussion regarding the district policy on social media and technology usage. A proposed policy has been provided by Secretary Marinello for review and will be discussed at the next monthly board meeting.

Chairman Indusi made a motion to enter an executive session to discuss litigation matters, Seconded by Commissioner Lichtenthal, All in Favor. The time is 8:52pm.

Chairman Indusi made a motion to exit the executive session, Seconded by Commissioner Lichtenthal, All in Favor. The time is 9:15pm.
