A motion was made by Commissioner Puszka, seconded by Commissioner Olenik to renew the Station 2 alarm monitoring agreement with Arcuri Alarms. All in favor.

A motion was made by Commissioner Olenik, seconded by Commissioner Schapiro to extend one year the Station 1 elevator maintenance contract with Otis Elevator Company. All in favor.

The Board gave the Fire Company permission to mount a 55" TV in the Station 1 Conference Room.

There was discussion regarding implementing COVID restrictions based on the surge in cases. The Board made a decision to require all members to wear masks (vaccinated or not) when in the firehouses and riding the apparatus. The exception is when a member is alone in an office, bay or gym. Captain Santone was requested to send an email notice to the members advising them of the revised policy and for the members to provide the District Secretary with proof of booster vaccination.

Commissioner Wolfensohn informed the Board that the New Castle Town Holiday Parade on December 18th was a great success.
